**SUBJECT:** DJ Flambe LLC d/b/a Million Dollar Cowboy Steakhouse - Request to Change Dispensing Room

#### STATEMENT/PURPOSE

The Town Council is the local licensing authority with respect to liquor licenses.

#### BACKGROUND/ALTERNATIVES

Mr. Paul O'Connor, also known as, DJ Flambe LLC d/b/a Million Dollar Cowboy Steakhouse maintains a valid restaurant liquor license for its premises located below the Cowboy Bar at 25 North Cache Street and is requesting Council permission to change the location of its dispensing room per the attached plans.

The current dispensing room can be described as a 7' x 7' room on the north side of the restaurant. The applicant wishes to "shift" the dispensing room location from the middle of the bar to one end of the bar. This would allow better flow for the restaurant and eliminate having a glass partition in front of seated customers at the bar. The new room will be described as an approximate 9' x 7' room on the north side of the restaurant. If approved, the applicant plans to begin the remodel immediately and reopen to the public in early December.

This design change has been reviewed and approved by the Wyoming Liquor Division and reviewed by Town staff.

Wyoming Statute Section 12-5-201 as it relates to a licensee's dispensing room provides, in part:

***12-5-201. Location, regulation and restrictions as to place of sale; inspections; additional dispensing rooms.***

*(a) Except as otherwise provided in this section, the principal place in which alcoholic liquor and malt beverages are sold under a license shall be located in one (1) room upon the premises for which the license is issued and as approved by the licensing authority. ... The licensing authority shall, as often as necessary, inspect the licensed room and adjoining rooms where alcoholic beverages are served to insure that the licensee is in compliance with sanitation and fire hazard requirements and other applicable laws.*

#### ALIGNMENT WITH COUNCIL'S STRATEGIC INTENT

Maintaining the business at the licensed premises supports the Town is Heart because it will attract locals and guests to the downtown area. It also supports Economic Sustainability as it is a location where sales will occur and generate sales tax revenues.
